PPE Product:

Portwest Bizflame Multi Style FR79 Two Tone lined jacket. Yellow and navy jacket with a plastic zip front fastening with a storm flap secured with Velcro. The garment has hip patch pockets with flaps secured by Velcro, an internal patch pocket and a mobile phone pocket beneath the front storm flap, and radio loops on the front chest. The garment has two bands of 50mm wide retroreflective tape about the torso and arms, and bands on each shoulder with reflective piping across the yoke. The garment has a hood which may be rolled up into the collar.

Portwest Bizflame Multi Style FR78 Two Tone Lined trousers. Yellow and navy salopettes with a zip (plastic) opening to the lower leg constructed with a Velcro secured flap concealing the zip. The garment has two bands of 60 mm wide retroreflective tape sewn about each lower leg.

Both the above garments are constructed with a 2 layer 320 g/m² laminated Twill outer fabric 80% Cotton, 19% Polyester, 1% Antistatic fibre with internally taped seams, with an FR cotton 170g/m² lining in navy. The garments are available in six nominal sizes the smallest size being size M.


