Portwest Style S476 Executive Vest, the garment is constructed from a 124g/m² warp knitted polyester fabric in Orange or Yellow. The garment features one band of retroreflective tape sewn on encircling the torso with over the shoulder bands. The garment has a clear identity badge holder on the right breast and a mobile phone pocket on the left breast and two lower bellow pockets with flaps. The garment is available in ten nominal sizes the smallest being S.





